

# Admissions

## **Principles**

All children who register with us will begivenequal rights regarding admissions regardless of their race, religion, disability, language, sexual orientation and gender. Statement of intent It is our intention to make Peter's Patchaccessible to all children and families. We strive to have a multicultural setting andencourage families from all backgrounds. ### **Procedures**

We aim to achieve this policy by ensuring the nursery is advertised in places accessible to all sections of the community.

Admitting our Pre-school children according to the set criteria.

Admitting the children according to our registration between the ages of 0-12. To secure a place for your child you will need to complete a registration form which will include information on fees (Day Care only), medical information and permission slips etc. Once the registration form and non-refundable registration fee have been received, a letter will be issued to confirm the place, start date, room and attendance pattern. Children joining Day Care will be required to pay a £100 non-refundable registration fee while children joining Forest School will be required to pay a £50 registration fee. Those joining Educational Preschool only are not required to pay a non-refundable registration fee.



When the nursery reaches its daily number of children, we will put names onto a waiting list. Preference will be given to siblings of those already attending on a first come basis depending on the needs of the family. Viewings of the nursery are available to book via the office. They are available Monday - Friday at 10.30am or 3pm and will last approx. 15 minutes. Covid guidelines are in place and must be followed at all times. More information is available from the office. Viewings of Education Preschool are available to book via the office. They are available Monday - Wednesday and Friday from 10am - 11pm and will last approx. 15 minutes. Covid guidelines are in place and must be followed at all times. More informationis available from the office.

### Educational Pre-SchoolAdmissions Criteria

A timetable of pre-school admissions procedures setting out the dates by which an application is to be submitted is available at www.eani.org.uk/admissions under 'Pre- School Admissions'.

During the admissions procedurewhenapplying the criteria punctual applications will be consideredbeforelateapplications are considered. The application procedure opens at thestartofJanuaryeachyear at 12noon (GMT) and an application submitted by the closingdateattheendofJanuary at 12noon (GMT) will be treated as a punctual application. Anapplicationreceived after 12noon (GMT) at the end of Januarywillbetreatedasalateapplication.

As the pre-school admissions procedure is in two stages the timetable also specifies the relevant dates at Stage 2 which will determine if an application is to be considered as punctual or late. Funded places can only be considered for children in their pre-school year born between relevant dates.



In the event of oversubscription, thefollowingcriteriawillbe applied in the order set down: 1. Children from socially disadvantagedcircumstanceswhowere born between relevant datessetinplace. 2. Other children born betweenrelevantdatessetin place.

Note: Children from 'socially disadvantaged circumstances' means a child whose parent is in receipt of (i) Income Support, or (ii) Income-based Jobseeker's Allowance, or (iii) an award of Income Support which has been converted into an Employment and Support Allowance and the level of benefit remains the same, or (iv) Universal Credit. When parents apply for places for their child on this basis they must provide Benefit Verification to confirm that they are in receipt of a qualifying payment. This should be provided to the Pre-School of first preference and the application procedure for Pre-School will outline how this can besubmitted.



#### Sub-criteria

If oversubscribed in any of the above criteria 1-2, the following sub-criteria will be applied in the order set down:

(a) Children who are currently attending Peter's Patch Day Nursery. (b) Children whose parent's home is the closest to the nursery as measured by walking distance, using Google Maps. The remaining places will be allocated on the basis of the initial letter of the surname (as entered on theBirthCertificate) in the order set down below:- A F S D H G K JLZCXVNBMQEWTRUYOIP

This order was determined by a randomised selection of the letters of the alphabet. In the event of surnames beginning with the same initial letter the subsequent letters of the surname will be used in alphabetical order. In the event of two identical surnames the alphabetical order of the initials of the forenames will be used.



### Duty to Verify

The Management Committee reserves the right to require such supplementary evidence as it may determine to support or verify information on any application form.

If the requested evidence is not provided to the Management Committee by the deadline given, this will result in the withdrawal of an offer of a place. Similarly, if information is supplied which appears to be false or misleading in any material way, the offer of a place will be withdrawn.
